PB Case #PB20-05 – Walter Wiacek – Request for a conditional use permit for earthmoving of more than 25 cubic yards and for a new foundation on a non-conforming structure in the Shoreland Zone at 83 Blackberry Lane (Town Map 23 Lot 11).

Rick – based on information from Don and Gary, we'll continue this case. We'll leave it to Mr. Wiacek and Mark to reschedule this case.

PB Case #**PB20-06** – Anthony Derosa – Request for a conditional use permit for earthmoving of more than 25 cubic yards and for a 30% expansion in the Shoreland Zone at 156 Heritage Woods Lane (Town Map 41 Lot 21).

Rick – would you like to give us a brief description of what you'd like to do? Tony – the camp is located 18 feet from the shoreline, the sill plates are all rotted and the building is starting to bulge towards the water. I would like to move the new camp 15 feet back from the lake. I've also redesigned the new structure to stay within the 20 foot height.

David – there are actually two buildings. The one near the lake Tony is proposing to replace and the second one at the top of the hill.

Rick – how deep is the lot? Ed – the town map shows 175 feet on one side, 188 on the other.

Mark – I spoke with Colin Clark and he considers the addition of the new deck to be an improper forward expansion.

Rick – I have a question concerning the 30% calculation.

Lou-Anne – I make a motion that we table PB Case #PB20-06 until the applicant has a chance to clean up the paperwork and represent.

Conrad seconded. Passed 7-0.

PB Case #PB20-07 – Terry Johnson – Request for a conditional use permit for earthmoving of more than 25 cubic yards and for a lateral expansion in the Shoreland Zone at 30 South Upper Narrows Lane (Town Map 33 Lot 4).

Rick – can you give us a recap on what you'd like to do? Terry – we'd like to remove the old dilapidated trailer and replace it with a single-story house. Also, build a garage across the road. Don – I don't see any reason to move the new structure back.

Ed – are you proposing a full foundation? Terry – yes, for a walk-out basement.

Rick – what's your timing? Terry – I'd like to get the foundation in and the home weather-tight before winter.

Ed – I move that PB Case #PB20-07 – Terry Johnson – request for a conditional use permit for earthmoving of more than 25 cubic yards and for a lateral expansion in the Shoreland Zone at 30 South Upper Narrows Lane (Town Map 33 Lot 4) be approved as submitted.

Gary seconded. Passed 7-0.

PB Case #PB20-08 – Gerald Fleury – Request for a conditional use permit for earthmoving of more than 25 cubic yards and for a driveway in the Shoreland Zone at 50 Forest Avenue (Town Map 37 Lot 57).

Rick – is anyone here for Mr. Fleury? Mark?

Don - I see there are trees to be removed? Mark - they're already gone but I wanted to make sure that they're replanted. The stumps will be ground down.

Ed – can we permit a driveway within 100 feet of the lake? Rick – it's a CEO item, the earthmoving is our only issue.

Don – without the applicant being available tonight, I have a number of questions.

Don – I move that we table PB Case #PB20-08 – Gerald Fleury – request for a conditional use permit for earthmoving of more than 25 cubic yards and for a driveway in the Shoreland Zone at 50 Forest Avenue (Town Map 37 Lot 57) until the applicant can appear.

Gary seconded. Passed 7-0.

PB Case #**PB20-09** – **Tyler Evans** – Request for a conditional use permit for earthmoving of more than 25 cubic yards in the Public Water Zone at Boot Cove Lane (Town Map 59 Lot 10).

Tyler – we'd like to build a camp and garage at the very end of Boot Cove Lane. I'm looking to pump up to a leach field located behind the house. I have a permit from DEP for a six foot wide, meandering walkway to the water.

Rick – are you trying to get started this season? Tyler – I'd like to complete the earthwork done and, get the septic and foundation in.

Ed – this drawing has all kinds of dimensions; thank you.
