Update – Maranacook Outlet Dam Project

Although some of the gate control equipment has arrived and has been installed, several key pieces of equipment still have not been received, nor has Obermeyer Manufacturing been forthcoming with shipping information. General Contractor H.E. Callahan has been extraordinarily helpful and responsive, operating the dam gate with their own equipment and personnel as needed.

Update – Personnel

We have hired Vernice Boyce as Finance Director. She is currently Finance Director in Wiscasset, has been Town Clerk and Treasurer previously in two Washington County towns and spent 14 years as an auditor and audit manager for RHR Smith & Co.
