Item # 17 – Town Personnel Policy Discussion – Tabled from Feb meeting

Chapter 4, section 1.

Caprara would like to remove "what other towns are doing". Doesn't think it needs to be in the personal ordinance. Chair Fuller explained that it just references that Winthrop pays a competitive salary; Caprara doesn't believe it should read will pay competitive salary based on towns of similar size to Winthrop. Shouldn't be set on what other towns pay; should be what we are willing to pay. Jeff proposes to add objective criteria when deciding what someone should be paid; needs to be done for when budgets in April are being worked up. Chair Fuller this section isn't what the increase is; it only states that if we didn't have a certain position it helps to set a salary scale on comparable business and towns. Fitzgerald believes we should be competitive yet this language isn't the right method. Caprara the policy also has been used not just for hiring it is used to give raises and she does not support this. Fuller explained that it is very specific that it is not used for raises and is based on financial status of the town; does not state to be comparable. Fuller doesn't feel it should be changed just because it was used incorrectly for raises in the past. Police Chief explained that the Town's Charter has language to cover areas like this. Member of the public stated he is concerned and wouldn't want the town to waste to much more time on this subject matter and that employees coming in and saying I should get more money just because surrounding towns pay more. Henry expressed that things like this is where mandated to raise someone's pay if the finances are not there. If raises are given on merit we should always do so; yet promises if the funds are not there shouldn't be made. Fuller again explained that this isn't raises and it is not part of this section. Positions need to be looked at based on years. Lee Bragg suggested that leave the first line, delete the second line to comparable and leave it; delete the word

private. The objective of the town to pay the employees on a basis comparable to work in the area. To define the issue it is whether or not salary and wages stays in as a more specific or if comes out it becomes more general. Fuller believes by making more general opens it up even more for higher salaries. Fitzgerald is ok with the way it is and is also ok to make it a little more general. Fitzgerald suggests that we list criteria that could be used, possibly for years of experience, etc. Henry suggest at the end it states subject to change by the Council. Lee will work on the language with Caprara and Henry and bring before Council at next meeting. Chief asked if this was a problem; Caprara says it is a problem every year. Fuller reminded it is not for raises and not for Salary at hire. Priscilla is concerned that we are now spending money on legal cost. Lee suggest if strike out the second line; you then have Caprara's proposal and does the Council want this removed. The Council would like to leave in and add more criteria.
