Other Business:

Councilor Wess gave an update about the two ad hoc committees working on docks and moorings in the Norcross vicinity and the East Winthrop Beach and the Improvement Association. He is hoping that the work of these committees will be ready for discussion at a near future Council meeting.

Manager's Report:

Financial Update – Information about YTD revenues as measured against FY20 activity and FY21 budget was presented. In general, the Town's financial position remains strong, even in the face of pressures resulting from Covid disruptions.

Bond Sale – We did extremely well in the recent sale of the approximately \$4 million bond. The rate was an attractive 1.41%, our status was upgraded from negative to stable and analysts expect our A rating will become A+ based on current trends in the Town's financial management. We have saved in excess of \$300,000, closer to \$400,000.

Turtle Run Bridge – Although we produced plans for a replacement bridge in record time and have been circulating them among likely contractors, we have received little interest as contractors are out straight to complete obligations before winter. We are willing to pay a premium of approximately \$10,000 beyond estimates (cost rising from \$35,000 estimated to \$45,000) to get the bridge replaced before winter, but after that we will wait until spring and solicit bids again.

Implicit Bias Training – the Town's Management Team will participate in a regional Implicit Bias Training during the week of November 9. Each day management staff from Winthrop, Hallowell and Gardiner will participate in a two hour program. Augusta will participate in the same training, but as a single municipality given the number of their management staff. Police Department Crisis Intervention Training – the Winthrop PD was singled out as the "gold standard" by the National Alliance for Mental Illness - Maine recently while applying for Crisis Intervention Training. At the conclusion of this training round WPD will be 100% trained in these techniques, overwhelmingly beyond the 20% requirement. Thank you Chief Frost and WPD officers for your commitment to attain this status.

Other – One half of Memorial Drive will be reclaimed and paved in this year's upcoming program, beginning next week, marking a multi-year effort to improve the road. Approximately \$350,000 has been spent to date.
